BYLAW NUMBER 29/82.

A BYLAW TO DESIGNATE THE PROPERTY KNOWN  
MUNICIPALITY AS THE NORQUAY COMMUNITY CHURCH CEMETERY  
AS BEING OF ARCHITECTURAL, HISTORICAL OR NATURAL VALUE

WHEREAS Part III of The Heritage Property Act, 1980, authorizes the council of a municipality to enact bylaws to designate real property, including all building and structures thereon, to be architectural, historical or nature value or interest;

WHEREAS the Council of the Corporation of the Rural Municipality of Clayton No. 333 has caused to be served on the owners of the lands and premises known as The Norquay Community Church Cemetery located on all that portion of the South West quarter of Section Fifteen ( 15 ) in Township Thirty-four ( 34 ) in Range One ( 1 ) West of the Second Meridian, in the Province of Saskatchewan, in the Dominion of Canada, more particularly described as follows; Commencing at a point on the Western boundary, thirty-five ( 35 ) rods north of the South West corner of the said quarter section, running Easterly in a line parallel with the Southern boundary, a distance of Twenty-four ( 24 ) rods; thence Northerly in a line parallel with the Western boundary, a distance of Twelve ( 12 ) rods; thence Westerly in a line parallel with the Southern boundary, a distance of Twenty-four ( 24 ) rods, more or less; thence Southerly along the said Western boundary a distance of Twelve ( 12 ) rods to the point of commencement, a Notice of Intention to so designate the aforesaid property and has caused such Notice of Intention to be published in at least two issues of a newspaper with general circulation in the municipality with the first publication at least Twenty-one ( 21 ) days prior to the date of consideration of the bylaw and with the last publication at least Seven ( 7 ) days prior to the date of consideration;

WHEREAS no Notice of Objection to the proposed designation has been served on the clerk of the municipality;

THEREFORE the Council of the Corporation of the Rural Municipality of Clayton No. 333 enacts as follows:

1. There is designated as being historical or interest the real property known as The Norquay Community Church Cemetery located on all that portion of the South West quarter of Section Fifteen ( 15 ) in Township Thirty-four ( 34 ) in Range One ( 1 ) West of the Second Meridian, in the Province of Saskatchewan, in the Dominion of Canada, more particularly described as follows: Commencing at a point on the Western boundary, thirty-five ( 35 ) rods north of the South West corner of the said quarter section, running Easterly in a line parallel with the Southern boundary, a distance of Twenty-four ( 24 ) rods; thence Northerly in a line parallel with the Western boundary, a distance of Twelve ( 12 ) rods; thence Westerly in a line parallel with the Southern boundary, a distance of Twenty-four ( 24 ) rods, more or less; thence Southerly along the said Western boundary a distance of Twelve ( 12 ) rods to the point of commencement. The significance of the site is as follows: The said site was the first cemetery and church site in the Norquay Saskatchewan area.
2. The municipal solicitor is hereby authorized to cause a certified copy of this bylaw to be registered against the property above in the proper Land Titles Office.
3. The Clerk is hereby authorized to cause a copy of this bylaw to be served on the owner of the aforesaid property and on the Minister of Culture and Youth, and to cause notice of the passing of this bylaw.
