The Rural Municipality of Clayton No. 333 will participate in the AWSA's well decommissioning campaign for 2023 as follows:

- The cost of a well decommissioning (only large diameter, >24") is \$2,500.00 + tax (\$2775.00);
- The AWSA will be the contact for this initiative and will facilitate the entire process;
- The AWSA will provide the R.M. with the contractor invoice. The R.M. will be responsible for paying the contractor invoice;
- The AWSA will submit the rebate application form to the Ministry of Ag's Farm and Ranch Water Infrastructure Program, with the R.M. acting as the applicant on behalf of the landowner, to get the R.M. 90% reimbursement;
- The AWSA will provide the RM with \$100 reimbursement per well; and
- The R.M. will then invoice the landowner for the remaining balance of \$300.00.

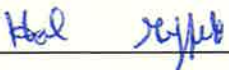
